- Verify your identity and compliance with firearms laws

- Comply with legal and regulatory obligations
- Improve and personalize your experience on our platform

#### 3. Disclosure of Information

We will not share your personal information with third parties except:

- When required by law or regulation
- With law enforcement or regulatory bodies for compliance (e.g., firearm licensing)
- With service providers (e.g., payment processors, IT service providers) under strict confidentiality agreements
- If you explicitly consent to such disclosure

## 4. Data Security

We are committed to securing your personal information. We use appropriate technical and organizational measures to safeguard your data, including:

- SSL encryption
- Firewalls and secure servers
- · Restricted access to personal data
- Regular backups and vulnerability testing

### 5. Your Rights (Under POPIA)
